2. **INCLUDE A COPY OF THE SALES RECEIPT.** Submit a copy of the sales receipt showing the product purchased and the purchase date (dated between 2/1/2020 – 2/29/2020)
3. **INCLUDE THE ORIGINAL UPC CODE.** Submit the proof of purchase by cutting out the original UPC bar code showing serial number from the side of the carton and the receipt showing the purchase of the machines selected above.
4. **SIGN THE CLAIM FORM.** This form must be signed in order to be valid.
