1. **COMPLETE THIS CLAIM FORM** Claims must be received by mail at the specific address for the offer. Claims cannot be received by e-mail.

2. **INCLUDE A COPY OF THE SALES RECEIPT.** Submit a copy of the sales receipt showing the product purchased and the purchase date (dated between 1/1/2017 - 1/31/ 2017)

3. **INCLUDE THE ORIGINAL UPC CODE.** Submit the proof of purchase by cutting out the original UPC bar codes from the side of the carton and the receipt showing the purchase of the machines selected above.

4. **SIGN THE CLAIM FORM.**
