2. **INCLUDE A COPY OF THE SALES RECEIPT.** Submit a copy of the sales receipt showing the product purchased and the purchase date (dated between 08/01/20 – 9/30/20)

3. **INCLUDE A COPY OF THE UPC CODE.** Submit the proof of purchase by sending a scanned copy of the UPC bar code from the side of the carton and the receipt showing the purchase of the machines selected above.

4. **SIGN THE CLAIM FORM.** This form must be signed in order to be valid.
